ELIGIBILITY:

- » **NOVICE ELIGIBILITY:** You may enter the novice class if you have never placed first in any class of any NPC contest.
- » **TEEN ELIGIBILITY:** You must be between 13 and 19 years old on the day of the contest.
- » **JUNIOR ELIGIBILITY:** You must be age 23 or under on the day of the contest.
- » **MASTERS ELIGIBILITY:** You must be of the minimum age for the class on the day of the contest (i.e. to compete in the 35 & OVER class you must be 35 or older). There is no upper age limit on any masters class, so you may compete in multiple groups.

HEIGHT/WEIGHT CLASSES:

- » **OPEN** height/weight classes are set to the NPC standards listed at <http://npcnewsonline.com/rules/>
- » **NOVICE** height/weight classes will set after check-in to ensure balanced and fair competition and announced at the athlete meeting.
- » **TEEN/JUNIOR/MASTERS:** One class per division (there are no height/weight divisions within each age group).
